INVITATION TO BID FOR
[Garden tools for livelihood Development through Integrated Farming Technology
Demonstration , municipality of Zarraga]

1. The *[Municipality of Zarraga]*, through the *[Trust Fund]* tends to apply the sum of *[P 167,650.00]* being the Approved Budget for the Contract (ABC) to payments under the contract for *[Garden tools for livelihood Development through Integrated Farming Technology Demonstration , municipality of Zarraga]*. Bid received in excess of ABC shall be automatically rejected at bid opening.
2. The *[Municipality of Zarraga]* now invites bids for *[Garden tools for livelihood Development through Integrated Farming Technology Demonstration , municipality of Zarraga]*. Delivery of the Goods is require *[March 13, 2020]*. Bidders should have completed, within *[28 days]* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents particularly in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - a. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
4. Interested bidders may obtain further information from *[Municipality of Zarraga]* and inspect the Bidding Documents at the address given below during *[8:00 AM to 5:00 PM]*.
5. A complete set of Bidding Documents may be purchased by interested Bidders on *[February 17 to 27, 2020]* from the address below and upon payment of a nonrefundable fee for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
6. ***If the Procuring Entity intends to open the Pre-Bid Conference to all interested Bidders:***
 - a. Bids must be delivered to the address below on or before *[8:45 AM on February 28, 2020]*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause.
 - b. Bid opening shall be on *[9:00 AM on February 28, 2020]* at *[municipality of Zarraga, Zarraga, Iloilo]*. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.
7. *All sealed bids must be delivered by the authorized representative at the BAC Office one (1) day before the opening of bids;*
8. The *[Municipality of Zarraga]* reserves the right to accept or reject any bid, to annul the bidding process to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
